- I. **CALL MEETING TO ORDER** – Chairman/Vice-chairman. Chairman Abrego convened the regular meeting of the Board of Trustees at 5:01 p.m.

Trustees: Chairman Abrego, Trustee Monasterio, Trustee Donahue, Trustee Knox, Trustee Binion

II. **APPROVAL OF AGENDA OR ADDENDUMS** – Chairman/Vice-chairman. Prior to the agenda items, Chairman Abrego asked if there was a motion to approve the agenda. Trustee Binion motioned to approve the agenda, with a second from Trustee Donahue. Motioned approved.

III. **EXECUTIVE SESSION** – Student Matters
Executive Session – Title 33, Chapter 5, Section 33-205 – Denial of School Attendance, and Title 74, Chapter 2, Section 74-202(4)(c)(6)(b) – Open Meeting (Special Meeting), 74-206(1)(b) – To consider the evaluation, dismissal, or disciplining of a public school student(s), Idaho Code.

Chairman Abrego called for a motion for the purpose of allowing the board to enter into executive session to discuss student matters. Trustee Binion motioned to enter into executive session in accordance with Idaho Code to discuss student matters, received a second from Trustee Donahue, the following resolution was presented:

And no less than two-thirds (2/3) of the membership in favor thereof, the Chairman declared said resolution adopted and the board recessed into executive session at 5:03 p.m.

ACTION ITEM(S):

A. Expulsion Hearing – Student A

Others present: The attending board members, Superintendent Gilbert, Clerk Whitman, Principal Gunderson, Vice-principal Cotton, (Names on File).

Following a full and complete discussion of student matters regarding a possible student expulsion, the board reconvened into open session at 5:52 p.m. A motion by Trustee Monasterio to reassign Student A (Name on File) to Bennett Mountain High School for the remainder of the 2016-17 school year, and until the end of the first semester of the 2017-18 school year. Student A may be re-admitted to Mountain Home High School after the 1st semester of the 2017-18 school year only upon a review conducted by the Superintendent, BMHS administrator, and MHHS administrator, received a second from Trustee Binion. In addition, the board stated that Student A was not permitted to participate in any extracurricular activities including athletics and he was not allowed to attend functions or athletic events at school. Motion granted.

B. Expulsion Hearing – Student B

The board entered back into executive session at 5:54 p.m. Others present: The attending board members, Superintendent Gilbert, Clerk Whitman, Principal Gunderson, Vice-principal Cotton, (Names on File).

Following a full and complete discussion of student matters regarding a possible student expulsion, the board reconvened into open session at 6:31 p.m. A motion by Trustee Binion to reassign Student B (Name on File) to IDLA to conclude his high school education, was seconded by Trustee Knox. In addition, the board stated that Student B was not permitted to participate in any extracurricular activities including athletics; he was not permitted to take part in any school building graduation ceremonies, and he was not allowed to attend functions or athletic events at school. Motion carried.

C. Expulsion Hearing – Student C

The board entered back into executive session at 6:36 p.m. Others present: The attending board members, Superintendent Gilbert, Clerk Whitman, Principal Gunderson, Vice-principal Cotton, (Names on File) and other family members.

Following a full and complete discussion of student matters regarding a possible student expulsion, the board reconvened into open session at 7:18 p.m. A motion by Trustee Donahue to reassign Student C (Name on File) to IDLA for the remainder of the 2016-17 school year, and should Student C decide that he would like to continue his education in the Mountain Home School District, he may request an Intake Interview to BMHS before the start of the 1st semester of the 2017-18 school year. In addition, the board stated that Student C was not permitted to participate in any extracurricular activities including athletics and he was not allowed to attend functions or athletic events at school. Motion approved.

D. Expulsion Hearing – Student D

The board entered back into executive session at 7:20 p.m. Others present: The attending board members, Superintendent Gilbert, Clerk Whitman, Principal Gunderson, Vice-principal Cotton, (Names on File), other family members, and friends.

Following a full and complete discussion of student matters regarding a possible student expulsion, the board reconvened into open session at 7:50 p.m. A motion by Trustee Binion to reassign Student D (Name on File) to IDLA to conclude his high school education, was seconded by Trustee Monasterio. In addition, the board stated that Student D was not permitted to participate in any extracurricular activities including athletics; he was not permitted to take part in any school building graduation ceremonies, and he was not allowed to attend functions or athletic events at school. Motion passed.

- IV. **ADJOURNMENT** – All business of the Board having been completed, Chairman Abrego called for a motion to adjourn. A motion from Trustee Binion to adjourn was seconded by Trustee Donahue. Motion granted. Meeting adjourned at 8:00 p.m.
