Chairman Alexander called the special meeting of the Board of Trustees of Mountain Home School District No. 193 to order, at 9:00 a.m.

I. **EXECUTIVE SESSION** – Student Matters. Chairman Alexander called for a motion for the purpose of allowing the Board to enter into executive session for student hearings regarding possible expulsions. <u>After a full and complete discussion and upon motion duly made by Trustee Donahue and seconded by Trustee Checketts, the following resolution was presented:</u>

33-512, and Title 67, Section 67-2345(1)(b), Idaho Code.

BE IT FURTHER RESOLVED That following the executive session, the Board of Trustees will convene into public session for further business or adjournment of the meeting.

And no less than two-thirds (2/3) of the membership in favor thereof, <u>the Chairman declared said</u> resolution adopted and the Board recessed into executive session at 9:00 a.m. Others present: The attending Board members, Superintendent McMurtrey, Assistant Superintendent Gilbert, Clerk Whitman, Vice Principals Gunderson and Abbott, (Name on File), (Name on File), and Officer Howley (Probation Officer). Following a full and complete discussion of student matters regarding the possible student expulsion, the Board reconvened into open session at 9:33 a.m. <u>A motion by Trustee Donahue to deny attendance to (Name on File) to Mountain Home School District for violation of the MHSD Zero Tolerance policy and on the basis that his presence in public school is detrimental to the health and safety of other students and staff. Trustee Checketts seconded the motion. Motion approved.</u>

The Board entered back into executive session to hear the second hearing for a possible student expulsion at 9:37 a.m. Following a full and complete discussion of the student expulsion hearing, the Board reconvened into open session at 10:00 a.m. Others present: The attending Board members, Superintendent McMurtrey, Assistant Superintendent Gilbert, Clerk Whitman, (Names on File), and (Name on File). <u>A motion by Trustee Donahue to reassign (Name on File) to the APC for the remainder of this school year and reassign her to BMHS for SY14-15, upon the approval of the BMHS administration staff, received a second by Trustee Checketts. Motion granted.</u>

II. ADJOURNMENT – All business of the Board having been completed, Chairman Alexander called for a motion to adjourn. <u>A motion from Trustee Donahue to adjourn was seconded by Trustee Checketts.</u> <u>Motion approved.</u> The meeting adjourned at 10:02 a.m.
