I. **CALL MEETING TO ORDER** – Chairperson/Vice-chairperson. Chairman Abrego convened the regular meeting of the Board of Trustees at 7:30 p.m., and asked that all cell phones need to be off or muted.

- II. **APPROVAL OF AGENDA OR ADDENDUMS** Chairman/Vice-chairman. Prior to the consent agenda items, Chairman Abrego asked if there was an addendum to the agenda, or if there was anything to add or remove. Chairman Abrego called for a motion to approve or amend the agenda. <u>Trustee Binion moved to approve the agenda as published, with a second from Trustee Donahue. Agenda approved.</u>
- III. **CONSENT AGENDA ITEMS** Board of Trustees. Chairman Abrego called for a motion to approve the consent agenda items. Chairman Abrego asked for clarification about the bills regarding the vandalism and whether the district would be reimbursed for the expenses. Mr. Ogborn explained that the district would be reimbursed for most of the cost of the vandalism. <u>Trustee Monasterio moved to approve the consent agenda</u>, with a second from Trustee Binion. Motion granted.

- **A.** Vanessa Sabol MHHS Student and ASB President, approached the board on behalf of the MHHS student body regarding the reasons told to the students for having to remove the student artwork from the parking lots. She addressed some of the reasons given students for not allowing the artwork in the parking lot and offered some options and compromises to possibly rectify the situation. She also requested that some sort of compromise be agreed upon.
- **B.** Joe Garrett Centennial High School Student Protestor asked that the school district make compromises within the school district's policies and procedures to allow the artwork to remain in the parking lot. He then accused the school district of wanting the parking lot artwork removed because of his assumption that it was a policitcal stance. He continued to make accusations and an attempt to promote his political stand on social issues and civil liberties.

Chairman Abrego informed the audience the Superintendent Gilbert would address this matter in his Superintendent's Report.

The board thanked him for his presentation and commended him for the full day kindergarten and the positive atmosphere.

C. SUPERINTENDENT'S REPORT – James Gilbert. Mr. Gilbert addressed the students for having the courage to attend the board meeting.

Mr. Gilbert applauded the students for their conviction and informed them that they had done nothing wrong and that Mr. Gilbert supported them and supported the protest. He said the issue had become a bigger issue in part due to the news media (Channel 2 and Channel 7) who also attended and recorded the first part of the board meeting. He added that he had an issue with the media portraying the matter as something it was not. Mr. Gilbert informed everyone that the artwork in question is not controversial in any way, but it's being portrayed that it is the driving force behind the decision to remove all of the artwork.

Mr. Gilbert said the issue that was created was created by adults and not by the kids. He added that there is a procedure in place regarding projects of this magnitude and it has to be approved at the district level. Mr. Gilbert explained the reason for the district approval was to ensure certain projects meet all the different kinds of codes and regulations and had absolutely nothing to do with what was painted in the different parking spots.

Mr. Gilbert informed everyone that what he loves about Mountain Home is the diversity and that we as community members in this town get to embrace it because it doesn't occur in many places in Idaho. He continued to say that our town's diversity is what makes our town. Mr. Gilbert thanked the community members in attendance for showing the kids that sometimes in life things are important enough that you have to stand up for what you believe in. He applauded the parents for raising kids that are willing to coming to a school board meeting, wiling to protest, willing to take a stand on this issue.

Mr. Gilbert reiterated that this was a process that should have gone through appropriate channels and it didn't, so now we are in a situation, and this should have been addressed prior to the painting of the parking lot ever having gone forward, and now we're at a position of how do we move forward, and at the moment he didn't have any idea of how to move forward. He did say that a compromise could be made and that possibly another area could have been used for the artwork, but not the parking lot; he added that he hadn't even thought that far ahead with regards as to when to remove all the artwork from the parking lot because his concern was how to make sure the kids were treated fairly by the community.

Mr. Gilbert concluded by stating that he would like to meet with Vanessa to discuss some of his ideas on how to move forward. He then thanked the kids and the parents.

Chairman Abrego called for a 5-minute recess to allow those who didn't want to stay at the board meeting to leave.

VII. UNFINISHED BUSINESS -

A. APPOINTMENT TO TRUSTEE ZONE-1 POSITION – Chairman Abrego. Chairman Abrego informed the audience that each trustee had conducted their own interviews individually with the four applicants to determine who would best serve this district. He then gave a brief description of what the board was looking for in an applicant.

Chairman Abrego opened up nominations for Trustee Zone-1. Trustee Donahue nominated Kristina Knox and Trustee Binion seconded the nomination. Chairman Abrego nominated Dan Day. There being no other nominations, Chairman Abrego closed nominations. He then stated that Kristina Knox having

had two nominations and Dan Day had one, asked if the board approved appointing Kristina Knox as Trustee Zone-1. Trustee Monasterio asked to poll the board to ensure clarity of the nomination. Chairman Abrego then polled the board.

Mr. Longhurst presented the revisions to the 2016 Special Education Manual; the last revision was made in 2015. He then reviewed some of the changes, and asked for the Board's approval of the manual. Trustee Donahue motioned to approve the 2016 Special Education Manual revisions as presented by Mr. Longhurst. Trustee Binion seconded the motion. Motion granted.

Trustee Donahue seconded the motion. Motion carried.</u>
