The Policy Committee will have its first meeting October 12 - 3: 30 p.m. – DO Conference Room or Zoom – the following policies/procedures/non-policy procedures/forms may be reviewed/revised/adopted/deleted during this school year and can be found on the district website under Departments>Policies & Procedures>Policy Review. The Policy Committee Meeting schedule is on the districtwide calendar, which is found on both the building webpage and the district webpage, generally the second Tuesday of each month. The schedule may change at any time.

Only those policies in cycle that are being <u>adopted</u>, <u>deleted</u>, <u>or revised</u> will go before the Board for <u>three readings</u>. Policies that are being reviewed with no changes, or being deleted, or are considered an emergency, or as directed by state and federal laws, will go before the Board for <u>one reading only</u>. The exception is the Continuous Improvement Policy, which goes before the board for one reading only. Non-policy Procedures are approved by the Policy Committee and not by the Board.
