# <u>TITLE I PROCEDURE 1 – DISTRICT-WIDE PARENT & FAMILY ENGAGEMENT PROCEDURE/PLAN</u>

#### PART I. GENERAL EXPECTATIONS

Mountain Home School District agrees to implement the following statutory requirements:
